# **RESEARCH EXPERIENCE**

- American Bar Foundation, Project Development, "Disabling Asylum": I am currently conducting an exploratory research project, "Disabling Asylum," that asks how the current US administration is disabling asylum and related forms of sanctuary in the US, and how people are responding to this disablement. This project focuses on shifts in legislation, executive orders, militarized policing, ICE raids, the targeting of asylum courts and hearings, and other forms of state violence. I am currently conducting ethnographic activities such as gathering relevant legislation and executive orders, conducting participant observation at protests outside detention centers, participating in NGO trainings, writing country condition declarations to support asylum cases, engaging in court watch, and other related activities.
- Applied Research Laboratory for Intelligence and Security, University of Maryland: I participated in a 10-week summer program, Research for Intelligence and Security Community (RISC), part of the Applied Research Laboratory for Intelligence and Security (ARLIS), housed at the University of Maryland. My participation involved working closely with two colleagues to conduct a collaborative literature review on the sociocultural dynamics of "wargaming." At the end of the program, we presented our 40-page review to government officials and ARLIS researchers.

2021-2022 **Quito, Ecuador / Champaign, Illinois:** 12 months of ethnographic doctoral research involving in-person participant observation, in-person and remote

interviews, archival research, and digital communication with Colombian refugees, NGO workers, and government bureaucrats based in Quito, Ecuador. The question that guided this research is how refugees experience and navigate violence, persecution, and displacement in spaces and at times of supposed peace and refuge in the Global South.
